

### Who qualifies for this program?

### Business Partner Membership Terms and Condition:

1. New applicants must present all of the following required documents during application stage - Identification Card (IC), Company documents, Bank Account , Business Card, Passport size photo of the applicant(s).
2. A fee of RM300.00 is required for approve applicants.
3. 365 days 50% off is applicable to the highest price value only.
4. Business Partner Program can apply in all SSFHOM Showrooms and SSFHOM website
5. Approval status of Business Partner shall be from SSFHOM Headquarter.
6. A Business Partner Card is not a credit card or charge card.
7. For Business Partner who have not receive or fail to show Business Partner card, you can present your Identification Card (IC) and the Business Partner confirmation email to the cashier to be entitled to the benefits.
8. For Business Partner who receive Business Partner card. Principal and authorised purchaser with photo on the card is entitled to the benefits and the Business Membership card must present upon every purchase for validation purpose.
9. Business Partner program is valid for 1 year only upon card issuance.
10. In the event that a card is expired or cancelled, all rebates will be considered null and void.
11. An additional one (1) supplementary Business Partner card will be given upon request. This is free of charge.
12. For a lost or damage card, a fee of RM50 will be charged for card replacement.

### Business Partner Commission Terms & Conditions:

1. Commission is only applicable to SSFHOM Business Partners.
2. Business Partner members will enjoy commission rate up to 10%

RM10,000 - RM19,999 (5%)	RM20,000 - RM49,999 (7.5%)	RM50,000 and above (10%)

3. Commission rate is based on every 3 months (1 period = 3 months) total spending. If total target spending is not achieved, commission will not be given.
4. Total spending of 1 period is not allowed to be carried forward to the next period.
5. The additional annual bonus will be given based on the total spending in 1 year.
